  - (c) To acquire, by purchase, contract, donation, legacy, gift, grant, bequest or otherwise, any personal property and to enter into and carry out any agreements, contracts or undertakings incidental thereto, and to sell, dispose of and convey the same, or any part thereof, as may be considered advisable;
  - (d) To acquire by purchase, lease, devise, gift or otherwise, real property, and to hold such for the actual use and occupation of the Corporation or for carrying on its undertaking and, when no longer so necessary, to sell, dispose of and convey the same or any part thereof:
  - (e) To publicize the objects and activities of the Corporation;
  - (f) To publish and circulate papers, treaties, books and other publications and any and all aspects of the aforesaid;
  - (g) To enter into any arrangements with any authorities (public, academic or otherwise) or other persons that may seem conducive to the Corporation's objects or any of them and obtain from any such authority or person any rights, privileges and concessions which the Corporation may think it desirable to obtain and to carry out, exercise and comply with any such arrangements, rights, privileges and concessions;
  - (h) To hold, manage, sell, or convert and of the personal property from time to time owned by the Corporation, and to invest and re-invest any principal in such manner as may be from time to time be determined by the directors;
